FOR GOOD AND VALUABLE CONSIDERATION, Actor/Location agrees as follows:

Use of Name and Likeness.

(a) Actor/Location hereby consents and grants to the Millburn Township Public Schools, the Millburn Education Foundation, and the Millburn FilmFest the royalty-free, irrevocable right and permission to use in perpetuity Talent's name, likeness, biography, and/or voice, either alone or accompanied by other material, in connection with the submitted film or any promotional or advertising relating thereto, in any manner and in any media, throughout the world, at any time, including for public relations, public information, student recognition or awards, student competitions entered into by the student, instruction, distribution or sales where the proceeds benefit the Millburn Township Public Schools, the Millburn Education Foundation, or the Millburn FilmFest. The Actor/Location waives all rights to inspect and approve the finished product, its use or such written or spoken copy as may be used in connection therewith.

(b) Actor/Location acknowledges that any pictures or voice recordings taken of Actor/Location on a film submitted to the Millburn FilmFest and any pictures submitted by Actor/Location are or will become the sole property of the Millburn Township Public Schools, the Millburn Education Foundation, and the Millburn FilmFest. If Actor/Location receives any print, negative, or other copy thereof, Actor/Location shall not authorize its use by anyone else.

(c) Actor/Location will not hold the Millburn Township Public Schools, the Millburn Education Foundation, and/or the Millburn FilmFest responsible for any liability resulting from the use of Actor/Location's name, likeness, or photograph(s) in accordance with the terms hereof, including what might be deemed to be misrepresentation of Actor/Location, Actor/Location's character, or Actor/Location's person due to distortion, optical illusion, or faulty reproduction that may occur in the finished product.

(d) Nothing in this Agreement will constitute any obligation on the part of the Millburn Township Public Schools, the Millburn Education Foundation, and/or the Millburn FilmFest to make any use of any of the rights granted by Actor/Location under this Agreement.
